MATTERS® works to improve care outcomes for those with substance use disorder through its rapid referral platform, robust follow up and support services, network of harm re-duction vending machines and direct-mail supplies, and through targeted public health education campaigns. As the opioid crisis evolves, MATTERS has strategically pivoted to meet individuals and organizations where they are by bridging gaps and integrating support. MATTERS has since implemented a multifaceted approach to treatment, harm reduction, and marketing that prioritizes and leverages existing community-based resources. In this session, MATTERS leadership will review the outcomes and efficacy of a variety of strategies to directly engage both people who use drugs (PWUD) and the communities that serve them and how New Jersey can leverage a Rapid Referral platform to improve connections, access and outcomes for PWUD in our State.

#### 10:35 am - 11:35 am - "On the Front Line": Incorporating Prehospital Data and EMS to Combat the Opioid Crisis

This session will explore the utilization of emergency medical services (EMS) data and EMS clinicians to combat the opioid epidemic in participants' jurisdictions. It will highlight New Jersey's combined collaborative efforts with EMS, law enforcement, as well as local and state public health agencies. Through this collaboration, stakeholders monitor suspected opioid and other illicit drug overdoses and identify surges through "hot spot" geo-mapping, as well as implement medication-assisted treatment (MAT) in the prehospital setting. Additionally, this session will discuss "Five Minutes to Help,"; an innovative program aimed at providing EMS clinicians with a better understanding of Substance Use Disorder (SUD), addressing stigma, Harm Reduction, and changing behaviors at the prehospital provider level. The program emphasizes the critical role of EMS providers, who often are the only healthcare professionals interacting with non-fatal overdose patients.

#### 1pm-2pm – EMS' Role in Recognizing Substance Use Disorder (SUD) and Human Trafficking

This multidisciplinary session equips EMS professionals to detect and respond to signs of Substance Use Disorder (SUD) and human trafficking while on scene. Speakers will share lessons from region-wide deflection and outreach initiatives, and will outline investigative red flags drawn from complex trafficking cases. Covenant House New Jersey and the New Jersey Attorney General's Office will add a trauma-informed, victim-centered perspective and highlight statewide resources. Attendees will leave with actionable strategies to strengthen interagency coordination and deliver compassionate, effective care to vulnerable individuals.

Harm reduction is a health approach and a movement for social justice that reduces the risks surrounding drug use without requiring behavior change (e.g., abstinence), providing support and supplies to improve safety and health. It acts as an important entry point into care for people often disconnected from healthcare. In New Jersey, harm reduction agencies offer services like syringe access, naloxone distribution, testing strips, and education. EMS, hospitals, and healthcare providers can also now provide harm reduction supplies, supported by recent state laws. Personal stories show how respectful, brief EMS interactions and access to harm reduction can make a big difference, especially when patients are not ready or interested in formal treatment.
